

# SIZES DIMENSIONS



"Believe me, I know what you are thinking...it's tiny! Would it be a surprise if I told you that I am 6ft, 6 and can easily fit into the pod and I have ample space?

It's like a tardis! Even a Fiat 500 can legally tow our IVA inspected Henkipod"

Standard unbraked models external dimensions
Gross trailer weight: 500kg (the maximum the trailer can be legally, equals the weight of the trailer plus the weight of the 'podders' belongings and is the maximum the suspension is certified for)

Net trailer weight: averages out at 340kg (the weight of the finished trailer only but this depends on the model)

Nose weight: (weight pressed down onto the towball of the towing vehicle): On average 60kg (depending on model)

Length including hitch: 320cm
Width including wheel arches: 165cm
Height floor to top of roof vent: 163cm
Bed dimensions: 180cm long by 130cm wide

Colour matched roof vent in order for essential ventilation to prevent carbon monoxide poisoning



Side door with aluminium porthole window and lockable door. All of our fittings are quality stainless steel so that they do not rust



Colour matched front locker that houses the gas bottles plus additional storage that is lockable



240 volt electric hook-up dependent on model or as an optional extra



Opening porthole window. Two-way lockable night latch.



## FREQUENTLY ASKED QUESTIONS

### WHO MAKES THE HENKIPODS?

All of the Henkipods are produced in North Yorkshire. Most of the parts and components are sourced from manufacterers in the UK. We are proud to be British and believe in putting money into our own economy rather than cheaper imports.

### WHERE CAN I VIEW A HENKIPOD?

At the moment, you can only view the Henkipod at our premises in Leeming Bar, North Yorkshire. Unless you are lucky to see one of our customers out and about, you will need to visit us in Yorkshire. That is why we have given you extensive video content and pictures on our website and social media platforms. You shouldn't need an excuse to visit North Yorkshire and experience all it has to offer but if you did, we promise that we will make you a good cup of Yorkshire tea and talk through your dream Henkipod. We are hoping to showcase our Henkipods soon across the country. Watch this space! Please join our mailing list or keep up to date with us on the website and social media as to where we are exhibiting.

### **CAN I INSURE A HENKIPOD?**

You certainly can! We strongly suggest that you do insure your Henkipod. Please contact us for further information.

### DOES THE HENKIPOD NEED A ROAD TEST?

All Henkipods will be put through the DVSA's IVA trailer test to ensure that they are legally able to be towed on the road. The IVA is a strict test and each Henkipod is scrutinised by DVSA inspectors. This test is at no additional cost to yourselves and happens before you receive your Henkipod. We also provide you with the paperwork and validation certificate. We believe in quality and keeping our customers safe and we would never put a pod on the road until it was assessed and passed with the DVSA.

### WHO MAKES THE HENKIPODS?

All of the Henkipods are produced in North Yorkshire. Most of the parts and components are sourced from manufacterers in the UK. We are proud to be British and believe in putting money into our own economy rather than cheaper imports.

### WHAT ELECTRICS AND TOWBAR DO I NEED?

You will require either a fixed or detachable towbar with a nose weight capacity of at least 60kg (most towbars have a capacity of at least 75kg). You will require either 7 pin or 13 pin electrics dependent on the Henkipod model. We can organise the fitting of this to your vehicle anywhere in the country.

### WHAT IS THE TOWING WEIGHT OF THE HENKIPOD?

The towing weights are:

- Net trailer weight: Approx. 340kg depending on model
- Gross trailer weight: 500kg (depending on suspension used)
- Nose weight: Approx. 60kg (depending on model)

















### HOW DO I ORDER A HENKIPOD AND HOW MUCH DOES **EACH MODEL COST?**

You can order directly from our website and pay just 10% of the final Henkipod price to start your Henkipod build. 12 weeks before the delivery date, an additional 40% deposit will need to be paid to bring the overall deposit to 50%. The final 50% will need to be paid before collection or delivery. We strive to remain competative on the market but if the cost of materials keep rising, we have to raise our prices as per our terms and conditions. We also happily accept full payment.

We are working with a finance company at present to offer finance options in the near future. Final payment is needed before you take home your Henkipod. We will provide you with all of the relevant bank details for transfers and BACS payments.

### WHERE DO I COLLECT MY HENKIPOD AND ARE THERE **DELIVERY OPTIONS AVAILABLE?**

You can collect your Henkipod from our premises in Leeming Bar, North Yorkshire where we can go through the essentials and show you how to connect an awning and camping stove if you have selected these options.

We can also deliver at an additional cost and this depends on your location. We aim to deliver to as many places as possible but we cannot guarantee this service for everyone.

### DO HENKIPODS COME WITH A WARRANTY AND SERVICE PLAN?

All of our henkipods come with a one year warranty overall and a five year warranty on the fibreglass shell for water penetration. We also offer service plans and annual services should you wish to keep your Henkipod with regular healthchecks and tip-top condition. We are happy to look at any Henkipod or previously branded pods and our service team are here to help and look after you, regardless of when you purchased the Henkipod. We believe that our customers are part of our extended Henkipod family.

### CAN I CHOOSE MY OWN FABRIC AND UPHOLSTERY MATERIAL?

All of our Henkipods have a choice of fabrics and colour options but we don't like to stop our customers from being different and we cater for everyone. From colour matching to your car, vinyl wrapping and decals, we have made the Henkipod completely customisable. You can choose to have our standard fabric options or upgrade to our more luxurious quilted upholstery or even choose your own, our Henkipods are bespoke and made to order.

### **HENKIPOD ORDER - TERMS AND CONDITIONS**

- 1. Save as expressly provided in these conditions and the written contract between the parties, and except in the case of Consumer Sales (as defined by the Sales of Goods Act 1979), or in respect of death or personal injury caused by the Seller's negligence, the Seller shall not be liable to the Buyer and all warranties, conditions or other terms implied by the statute or common law as to the quality of the goods or their fitness for purpose are hereby excluded to the fullest extent permitted by law. Where the goods are sold under a Consumer Sale, the statutory rights of the Buyer are not affected by these Conditions.
- 2. Orders for the Goods, and offers of part exchange allowances for any used Henkipod or Carapod or 'The Pod', must be confirmed in writing by the Seller and accepted by the Purchaser, subject in either case to these Conditions, which shall govern the Contract. No variation to these Conditions shall be binding unless agreed in writing by the Seller.
- 3. The Seller's employees or agents are not authorised to make any representations concerning the Goods or part exchange allowances unless confirmed by the Seller in writing. In entering into the Contract, the Purchaser acknowledges that he does not rely on and waives any claim for breach of, any such representations which are not so confirmed.
- 4. Subject as hereinafter provided, no order which has been accepted may be cancelled by the Purchaser, except with the written consent of the Seller and subject to the Purchaser indemnifying the Seller in full against all loss (including the loss of profit), costs (including the cost of any labour and materials), damages, charges and expenses incurred by the Seller.
- 5. If within 14 days of receipt of written notification from the Seller that the goods are ready for delivery, the Purchaser fails to take or pay for the Goods, then, without any prejudice to any other rights it may possess, the Seller may cancel the Contract, appropriate any deposit paid for the Goods and charge the Purchaser interest on the amount unpaid at the rate of 4% above the base rate of Barclays Bank Plc from time to time until payment is made.
- 6. Risk of damage to or loss of the Goods shall pass to the Purchaser upon delivery of the Goods or payment in full for the Goods, whichever is the sooner.
- 7.Notwithstanding the provisions of Clause 6, the property in the Goods shall not pass to the Purchaser until the Seller has received full payment for the Goods together with the delivery of the used Henkipod (if any) offered by the Purchaser in part exchange.
- 8. Until such time as the property in the Goods passes to the Purchaser, the Seller shall be entitled at any time to require the Purchaser to deliver up the Goods and if the Purchaser fails to do so forthwith, to enter upon any premises of the Purchaser or any third party where the goods are stored and repossess them.
- 9. Any estimated date quoted for delivery, (the 'delivery date'), of the Goods is approximate only and the Seller shall not be liable for any loss suffered by the Purchaser arising from any delay in the delivery of the Goods howsoever caused.
- 10. In the event of the Seller accepting delivery from the Purchaser of a used Henkipod as part allowance of the price of the Goods, such allowances given and received,
- and such used Henkipod is hereby agreed to be delivered and accepted upon the following conditions:(a) (i) That such Henkipod is the absolute property of the Purchaser free from all encumbrances; or
  (ii) That such vehicle is the subject of a hire purchase or other encumbrance or encumbrances capable of discharge by the Seller, in which case the allowance shall be reduced by the amount required to be paid by the Seller in discharge of the encumbrance or encumbrances.
  (b) Fair wear and tear accepted, the Purchaser shall deliver the said used Henkipod to the seller in the same condition as at the Seller's examination of it or acceptance
- of it prior to confirmation and acceptance of this order and
- of it prior to confirmation and acceptance or this order and (c) Such used Henkipod shall be delivered to the Seller within 14 days of written notification to the Purchaser that the Goods are ready for delivery and upon delivery, property and risk in the said used Henkipod shall pass to the Seller, (d) If through no default on the part of the Seller the Goods shall not be delivered to the Purchaser within either 30 days from the date of Order or the estimated delivery date whichever is the later date, the allowance granted by the Seller on the said used Henkipod shall be reduced by an amount of 2.5% for each complete period of 30 days from the date mentioned above until the delivery of the Goods.
- 11. Failure by the Purchaser to comply with the foregoing Conditions (other than 10(d)) entitles the Seller to be discharged from its obligation to accept the said used Henkipod or make any allowance in respect thereof, and the Purchaser shall discharge in cash the full price of the Goods to be supplied to the Seller.
- 12. Notwithstanding the provisions of this Agreement, the Purchaser may, before the expiry of 7 days following receipt by him of notification that the Goods are ready for delivery arrange for a finance company to purchase the Goods from the Seller at the price payable hereunder upon the purchase of the Goods by such finance company, the preceding clauses of this Agreement shall cease to have effect but any used Henkipod for which an allowance was thereunder agreed to be made to the Purchaser pursuant and subject to Clause 10 shall be bought by the Seller at a price equal to such allowance and the Seller shall account to the finance company on behalf of the Purchaser for the said price and any deposit paid by him under this Agreement.
- 13. If the Goods to be supplied by the Seller are new, the following provisions shall have effect:
  (a) The Seller undertakes that he will ensure that the pre-delivery work specified by the Manufacturer or Concessionaire is performed and that it will use its best endeavours to obtain from the Manufacturer or Concessionaire the benefit of any warranty or guarantee given by it to the Seller or Purchaser,
  (b) Notwithstanding the sum for taxes specified in the order, the sum payable by the Purchaser in respect thereof shall be such sum as the Seller has legally to pay at the
- time the taxable supply occurs,
  (c) If after the date of this order and before delivery of the Goods to the Purchaser the Manufacturer's or Concessionaire's recommended price for the Goods shall be altered the Seller shall give written notice of such alteration to the Purchaser and, (i) If the alteration increases the price of the Goods this increase will be passed to the Purchaser, the Purchaser does not have the right to cancel the contract during the 12 week build time, failing which such increase shall be added to the contract price

  (d) In the event of the Manufacturer of the Goods described in the order ceasing to make goods of that type or specification then (whether the estimated delivery date has passed or not) the Sellers may at any time by notice in writing to the Purchaser cancel the Contract.
